Further, I certify that my child is physically fit and capable of participating in the activities for which he/she has registered. I give my permission for the free and unrestricted use of my child's picture in any telecast, broadcast, or written account of this program. I acknowledge my email address will be used exclusively by the Town of Cornelius for the purpose of sharing related information regarding this or other programs and will not be shared with any other parties.

COVID-19 PARTICIPATION WAIVER: In consideration of me, or my child/ward, being allowed to participate in the Town of Cornelius programs, related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. Participation includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my, or my child/ward's participation; and
3. I willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, I observe any unusual or significant hazard during my presence, I will remove myself and my child/ward from participation and bring such to the attention of the nearest official immediately; and,
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS the Town of Cornelius, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I have read this Release of Liability and Assumption of Risk Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement. I also certify that I, as parent/guardian, with legal responsibility for a minor participant, have read and explained the provisions in this waiver/release to my child/ward, including the risks of presence and participation and his/her personal responsibilities for adhering to the rules and regulations for protection against communicable diseases. Furthermore, I understand and accept these risks and responsibilities, and my child/ward understands and accepts these risks and responsibilities. I for myself, my spouse, and child/ward do consent and agree to my and his/her release provided above for all the Releasees, and myself, my spouse, and child/ward do release and agree to indemnify and hold harmless the Releasees for any and all liabilities incident to my, and/or my minor child's/ward's presence or participation in these activities as provided above, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent provided by law.

ACKNOWLEDGEMENT OF PROGRAM MODIFICATION: I also acknowledge that I fully understand and accept that the 2021 summer camps provided by Cornelius PARC will be vastly different as compared to pre-COVID camp years and camp activities and plans will be based on the most current directives or guidance in place at the time of each camp offering. Program modifications may include, but not be limited to, socially distanced camp activities, modified lesson plans and activities, location changes, modified drop-off /pick-up procedures, and lower enrollment maximums. Additionally, I acknowledge that all participants attending any camp held indoors OR outdoors may be required to use personal protective equipment such as cloth masks (with any requirements in effect for campers, staff, and instructors), depending on the local, federal or state guidance at the time that camp occurs. Campers must provide their own masks.

REFUND POLICY: In the event that a child cannot participate in a camp session in which he/she has registered, a 90% refund will be issued when requested by May 23, 2021. Beginning May 24, 2021, any cancellations made at least two weeks prior to the start of the registered camp week, will receive a 75% refund. If less than two weeks advance notice is given, a 50% refund will be issued. Once a camp has begun, no refund will be given. Please allow up to 30 days for refund processing. Additionally, if a child wishes to transfer from a camp in which he/she has registered to another available camp, a minimum of seven (7) days advance notice is required.

Please know that we value your participation in our programs and strive to provide the most positive camp experience possible. As we prepare for the 2021 Summer Camps, and in consideration of the COVID-19 health crisis, PARC continues to assess federal and state directives, the Governor's Executive Orders, and guidance issued by the North Carolina Department of Health and Human Services to ensure that camp programs are conducted in compliance with these orders and in the safest manner possible. To be upfront and clear, 2021 camp activities will be vastly different as compared to pre-COVID camp years, and plans will be based on the most current directives or guidance in place at the time of each camp offering. Program modifications may include, but not be limited to, socially distanced camp activities, modified lesson plans and activities, location changes, modified drop-off / pick-up procedures, lower enrollment maximums, and the required use of personal protective equipment such as cloth masks (with requirements in effect for campers, staff, and instructors) whether participating indoors OR outdoors.

Cornelius PARC fully expects that camps will continue to look and operate differently in 2021. In the event that planned activities change materially after registration opens or camp begins, whether due to a federal or state directive or other significant change associated with the pandemic, or due to a new federal or state health directive or other significant change that might affect the health and safety of campers, PARC staff will assess the refund process for affected camps within an appropriate timeframe that reflects the nature of the directive, type of significant change, and the period of time during which the directive or change is expected to last, and a full range of options will be considered. Additionally, if a camp is cancelled by PARC, participants will receive full refunds or department credits, or pro-rated refunds or department credits, for the portion of camp that cannot be offered.

BEHAVIORAL POLICY: It is very important that both parents and campers are aware of both the rules and subsequent consequences. All rules must be obeyed for the safety of everyone. If a participant chooses not to follow the camp rules, the parent will be asked to work together with the supervisor and the child to solve the problem. Parents will be notified of any problems that their child may cause in the program. **RULES:** Campers must follow directions of all camp staff and be considerate and respectful to other campers, their surroundings and others property. Campers should keep hands and feet to self. Fighting, hitting, kicking, use of profanity or name-calling will not be tolerated and could result in immediate suspension.

CONSEQUENCES & PROCEDURES:

1. Verbal warning by counselor.
2. Camper will be placed in time-out for five to fifteen minutes, depending on age of camper.
3. Verbal conference with camper, counselor and Camp Director.
4. Written disciplinary report completed and put on file by Camp Director. Parents will be notified, in writing, within one day regarding the written disciplinary report.
5. Two written disciplinary reports on one camper will result in, at minimum, a one-to-two-day suspension from camp. Days suspended will run concurrently. No refunds will be given in case of suspension.
6. Three written disciplinary reports will result in dismissal from camp for the remainder of the summer. No refunds will be given in cases of dismissal.

7. Depending on the severity of the offense, any and all steps in the Consequences & Procedures may be eliminated and/or combined.

LATE PICKUP/LATE FEE POLICY: Each child must be signed in/out each day by a parent or guardian, before and after camp. Parents or guardians may sign in campers up to 15 minutes prior to any camp starting time, when we will have camp staff onsite. For Summer Arts and Recreation Camps, parents or guardians may sign out campers up to 10 minutes after any camp ending time. Late Fees: We will allow a 5-minute grace period to pick up campers beyond the 10-minute camp pickup window noted above. If campers are picked up after the specified grace period, parents/account holders will be assessed a late fee of \$1 per minute, with start time for charges commencing at conclusion of the 10-minute camp pickup window.
